## **REPORTS OF COMMITTEES**

#### FINANCE

Mr. Notte referred to the Treasurer's Report for the month of January (copy attached), the monthly financial reports for Mott MacDonald and Cleary Giacobbe, and the vouchers. He recommended the vouchers be paid as presented.

#### **PURCHASING and PERSONNEL**

Mr. Kohle requested that approval of any Personnel Actions take place following Closed Session discussion.

# **PLANT OPERATIONS**

Mr. Schmidt referred to the Operations Report on the table. Mr. DeGraw reported that three major flood events occurred from late December to mid-January. The first flood event occurred on December 18 through December 23 and required 24/7 operations at the plant and three of the remote pumping stations. Mr. DeGraw reported that flows peaked as high as 30 mgd to the treatment plant. The second flood event occurred on December 28 through December 30. During that event, flows peaked at 19 mgd. The third flood event occurred on January 9 through January 14. The flows during that event peaked at 25 mgd.

Mr. DeGraw explained that the NJDEP was provided with daily updates during each of the events, no infrastructure damage occurred, and the staff did an excellent job operating and maintaining the treatment plant and the three major pump stations during all the events.

# **PLANNING and EXPANSION**

Mr. Boorady had nothing to report.

## **INSURANCE and LEGISLATIVE REVIEW**

Mr. Voorman had nothing to report. Ms. Holmes reported on one piece of legislation that was tabled in committee. This bill would exempt redevelopment that has been connected for over 20 years from a new connection fee.

#### **LEGAL and PUBLIC RELATIONS**

Mr. Runfeldt was absent.

# **MANAGEMENT REPORT**

Mr. Bongiovanni reported that at last month's Service Agreement meeting it was decided to discontinue discussions regarding revising the agreements for the time being. TBSA may revisit this endeavor once PRBRSA'S flow minimums are no longer a factor.

He referred to his Objectives for 2024 list on the table. He stated that there are 151 total tasks thus far and provided a summary status update. He noted that the roofing program is scheduled to start this year and will be an ongoing project for the next several years.

Mr. Bongiovanni discussed removing The Progress as one of our official papers. The paper only prints weekly which sometimes makes it difficult to publish legal notices on a timely basis. Mr. Bongiovanni noted that eliminating The Progress from our designated newspaper list will not reduce TBSA's legal posting coverage.

Mr. Scheri referred to the monthly Engineer's Report provided and brought the members up-to-date on all on-going projects.
