NOTICE TO BIDDERS

The Pequannock, Lincoln Park and Fairfield Sewerage Authority also referred to as Two Bridges Sewerage Authority or TBSA, located in Lincoln Park, County of Morris, New Jersey shall receive sealed proposals at the Administration Building, End of Lincoln Boulevard, Lincoln Park, New Jersey, until 11:00 A.M., prevailing time, **Tuesday, December 4, 2018**, and then publicly opened and read aloud in the Administration Building Conference Room for the **LABORATORY ANALYSES** bid.

Each proposal must be enclosed in a sealed envelope, bearing the name and address of the bidder and shall be addressed to the Two Bridges Sewerage Authority and delivered at the place and hour mentioned above. Envelope or Package must be clearly endorsed and marked, **"BID FOR LABORATORY ANALYSES"**

Copies of the specifications and contract documents for the proposed work are on file and open to public inspection or may be obtained at the Two Bridges Sewerage Authority, End of Lincoln Boulevard, Lincoln Park, New Jersey or by calling 973-696-4494 and requesting a mailing of the documents on and after Wednesday, November 21, 2018 between the hours of 9:00 AM and 4:00 PM, Monday through Friday, excluding legal holidays. Specifications may also be downloaded in PDF format on the internet at <http://www.tbsa.net>.

The work requires that samples be picked up at the Authority's wastewater treatment plant at the northerly end of Lincoln Boulevard in Lincoln Park, New Jersey. The site is available for inspection during normal office hours.

All bidders will be required to comply with Chapter 127 of the Public Laws of 1975, and the Public Laws of 1977, Chapter 33, listing all stockholders and partners who own ten percent (10%) or more stock or interest therein, or all individual partnerships who own a ten percent (10%) or greater interest therein, failure to provide the same is a non-waivable defect.

A certified check drawn on a National or State Bank or Trust Company, made payable to the PEQUANNOCK, LINCOLN PARK AND FAIRFIELD SEWERAGE AUTHORITY, or a bid bond shall accompany the bid. Said bid bond to be a guarantee that if the proposal is accepted a contract will be entered into and the performance of it properly secured as required. The certified check or bid bond shall be in the amount of 10% of the total bid not to exceed \$20,000.00.

Bidder must be registered with the State of New Jersey at time of the award of contract. Bidders will be required to present a copy of their Business Registration Certificate (BRC).

Bidders are required to comply with the requirements of N.J.S.A. 10:5-31 et seq. and N.J.A.C.17:27.

The Authority reserves the right to reject any or all bids, and to waive any informality therein, if, in its judgment, the interests of the Authority will be served thereby.
